**WAIVER, INDEMNITY AND HOLD HARMLESS AGREEMENT**

In consideration of and as a condition of issuance of any film permit to film/tape/create media production within the right-of-way and/or public utility easement and/or City Owned or Controlled Property of the City of Sterling Heights, (" Film/Production Company ") takes the following action:

- A. Film/Production Company assumes all risks of injury and property damage and accepts all responsibilities in the case of accident, injury or death, except for damages caused by or resulting from the City's sole negligence.
- B. Film/Production Company agrees not to sue the City of Sterling Heights, its employees, appointed and elected officials, volunteers and other individuals working on behalf of the City of Sterling Heights, for any claims, damages or costs which Film/Production Company may have as a result of any accident, injury or death incurred or suffered by Film/Production Company or its employees while conducting any film/video/media production activity, construction, operation, use and/or maintenance in the right-of-way and/or public utility easement and/or City Owned or Controlled Property, except for damages caused by or resulting from the City's sole negligence.
- C. Film/Production Company expressly agrees to the fullest extent permitted by law to indemnify and hold the City of Sterling Heights, its employees, appointed and elected officials, and volunteers and other individuals working on behalf of the City of Sterling Heights, harmless against any losses, costs, expenses, damages, liabilities, or claims whether groundless or not, arising out of bodily injury, sickness or disease, including death resulting at any time therefore, which may be sustained or claimed by any person or persons, or destruction of any property, (including the loss of use thereof) based on any act or omission, negligent or otherwise, of Film/Production Company or anyone else acting on its behalf incident to the Permit to film/tape/create media production, within the right-of-way and/or public utility easement and/or City Owned or Controlled Property, except that Film/Production Company shall not be responsible for indemnification to the City for damages caused by or resulting from the City's sole negligence; and Film/Production Company shall at its own cost and expense, defend any such claim and any suit, action or proceeding which may be commenced there under and Film/Production Company shall pay any and all judgments which may be recovered in any such suit, action or proceeding and any and all expenses, including but not limited to costs, attorney fees and settlement expenses which may be incurred therein as they relate in any way to any film/tape/media production activity, construction, operation, use and/or maintenance by Film/Production Company or others working on behalf of the Film/Production Company within the right-of-way and/or public utility easement and/or City Owned or Controlled Property.
