MINUTES OF THE ELECTION COMMISSION  
JUNE 4, 2025

Location: City Hall, Conference Room 106, 40555 Utica Road, Sterling Heights, MI 48313

1. Meeting called to order and roll call.

Chair May called the meeting to order at 6:01 p.m.

Commissioners present: Sara Dionne, Joseph Niman, Jr., Chelsea May, Deputy City Clerk

The Commission welcomed new member Sara Dionne.

2. Approval of Agenda

Motion by Niman, seconded by Dionne, to approve the agenda as presented.

3. Approval of Meeting Minutes of October 2, 2024

Motion by Niman, seconded by May, to approve the meeting minutes of October 2, 2024 as presented.

4. To review and approve ballot proofs for the August 5, 2025 Local Primary Election

Deputy Clerk May reported that staff proofed the ballots and found no errors. The Commission took some time to review the ballots and compare them to the Affidavits of Identity.

Motion by Dionne, seconded by Niman, to approve the ballot proofs and printing for the August 5, 2025 Primary Election and authorize the City Clerk to sign the Ballot Layout Sign-Off Form to be submitted to Macomb County Elections Department.

5. To consolidate precincts for the August 5, 2025 Local Primary Election

Deputy Clerk May noted that the City has 40 precincts at 28 locations. The Clerk's Office was notified that eight (8) polling locations would be inaccessible for the August Primary and one (1) of those locations would also not be available for the November General. City Council has approved temporary locations for those precincts. As a result, there will be 33 precincts in 21 locations for the August Primary.

Motion by Niman, seconded by Dionne, to consolidate precincts at the polling locations as identified by the City Clerk for the August 5, 2025 Local Primary Election.

6. To authorize early tabulation of absent voter ballots in accordance with PA 81 of 2023

Deputy Clerk May noted that MCL 168.765a (11) authorizes the Election Commission to approve up to eight (8) days of early tabulation of absentee ballots. She noted that while it is unlikely all eight (8) days will be needed, the Clerk's Office is requesting approval as a precaution, should the full duration become necessary. Early tabulation will take place in Seminar Room 2 of the Community Center for the August 5, 2025 Local Primary Election.

Motion by Dionne, seconded by Niman, to authorize the City Clerk to process and tabulate absent voter ballots between the hours of 7:00 a.m. and 8:00 p.m. on any of the 8 days before election day, beginning on the second Monday before election day and ending on the Monday immediately before election day; and instruct the city clerk to submit a written notice to the Secretary of State no later than 28 days before election day stating the specific days and times of early absent voter ballot processing and tabulation.

9. New Business.

- a. Early Voting

Deputy Clerk May noted that, given one-third of voters in the last election chose to vote early, five days of Early Voting will be offered at the Community Center. Sterling Heights ranked third

in the state for Early Voting turnout during the Presidential Election, highlighting strong voter interest in this option.

b. Temporary precinct location moves

As noted earlier, eight (8) precincts will be temporarily moved for the August 5, 2025 Primary due to extensive renovations at many Utica Community Schools and Warren Consolidated Schools. Temporary locations were approved by City Council at the June 3, 2025 meeting.
