

# SOIL EROSION AND SEDIMENTATION CONTROL (SESC) FEE SCHEDULE

All fees change July 1 of each year

The design engineer shall submit an itemized estimate of cost for all site improvements including the cost of SESC temporary and permanent measures for review by the Office of Engineering. Based on this estimate, the Engineering Review Fees will be calculated.

## 1. SESC Review Fees

The design engineer shall submit an itemized estimate of cost for all site improvements including the cost of SESC temporary and permanent measures for review by the Office of Engineering. Based on this estimate, the Engineering Review Fees will be calculated.

Commercial, Industrial, Multi-Family, Subdivision ..... ¼ of 1% of first \$ 500,000.00 +  
1/8 of 1% over \$ 500,000  
(\$50.00 minimum)

Single-Family Residential House ..... \$ 78.00 (as of July 2023)

Underground Private Utility ..... \$ 0.05 linear foot  
(\$50.00 minimum)

## 2. SESC Inspection Deposit

Inspection deposits shall be made in full prior to commencements of work in accordance with the following schedule:

MINIMUM		MAXIMUM	
\$ 0 - \$ 9,999	\$ 750	-----	\$ 750
\$ 10,000 - \$ 49,999	\$ 750	+ 1.5% of each \$1,000 over \$10,000	\$ 1,000
\$ 50,000 - \$ 99,999	\$ 1,000	+ 1% of each \$1,000 over \$50,000	\$ 1,250
\$ 100,000 - \$ 299,999	\$ 1,250	+ ½ of 1% of each \$1,000 over \$100,000	\$ 2,000
\$ 300,000 - up	\$ 2,000	+ ¼ of 1% of each \$1,000 over \$300,000	\$ 4,000
<b>Examples:</b>			
A) \$ 20,000; \$ 750 + 1.50% (\$ 10,000) = \$ 900 deposit			
B) \$ 80,000; \$ 1,000 + 1.00% (\$ 30,000) = \$ 1,300 (use \$1,250)			
C) \$ 200,000; \$ 1,250 + 0.50% (\$100,000) = \$ 1,750			
D) \$ 600,000; \$ 2,000 + 0.25% (\$300,000) = \$ 2,750			

## 3. SESC Bond

Cash, certified check, or irrevocable letter of credit from an approved financial institution equal in amount to the total cost of the soil erosion and sedimentation control measures and restoration of all disturbed areas (\$750.00 minimum).

4. SESC Inspection Rate

Per inspection .....\$53.00 (as of July 2023)

Per Inspection by Consultant.....Consultant fee +10%

5. SESC Permit Renewal Fee.....10% of SESC Review Fee  
(\$50.00 minimum)
