

Purpose

The Sterling Heights Parks and Recreation Department in conjunction with the financial support of Genysis Credit Union is currently accepting scholarship applications for those who need financial assistance to participate in eligible activities offered by the Parks and Recreation Department. This program is designed to assist Sterling Heights Residents financially by subsidizing a percentage of program fees.

Program Criteria

- Applicant must live at a residence within the city of Sterling Heights.
- Applicant must complete the application in its entirety. **Incomplete applications will not be considered.** In addition to this form, applicants must submit a brief statement explaining why they want to participate in desired activity.
- Family income must fall within the U.S. Federal Poverty Guidelines. Please see below.

- Application does not guarantee funds will be awarded nor enrollment in desired program(s). Scholarship funds are limited. The Scholarship Program may end at any time during the calendar year due to the available funding.
- Only Sterling Heights Parks and Recreation organized activities will be considered. Scholarship will not cover the cost of equipment.
- The Sterling Heights Parks and Recreation Department reserves the right to exclude certain programs from the Scholarship Application.
- Deadlines for applications differ from program to program. Please ensure ample time for review, award, and possible registration.
- Requests for program currently in progress will not be considered. The Scholarship Committee will not reimburse for activities already in progress.
- If you are awarded a scholarship, you will receive written notification, and direct payment will be made to the Sterling Heights Parks and Recreation Department on your behalf.
- If awarded, applicant must maintain 80% attendance during program. Failure to maintain attendance will result in revocation of scholarship.
- All information provided on the Scholarship Application is confidential and not released without written permission from the applicant.
